CONDITIONS

These are the conditions under which reproduction rights are granted for objects in the collections of the Ladies' Hermitage Association. The LHA is the parent organization of The Hermitage: Home of President Andrew Jackson and legal owner of the collections.

1. All requests for permission to reproduce an image for publication must be made in writing and include the intended use, publisher, and expected date of publication.
2. **The Publisher is to provide The Ladies' Hermitage Association with one complete gratis copy of the publication in which the image is reproduced.** Send this copy ATTN: Curator of Collections, The Hermitage, 4580 Rachel's Lane, Hermitage, TN 37076.
3. Reproduction is permitted only from negatives, prints, or transparencies supplied by The Hermitage. Color reproductions must be made from a 2 1/4" x 2 1/4" transparency or larger. All transparencies, negatives, and inter-negatives remain the property of The Ladies' Hermitage Association.
4. Each image must be reproduced unaltered and in its entirety unless approved in advance by The Hermitage. The reproduction must not be cropped, bled off the page, printed on color stock or with colored ink, nor have anything superimposed on the image. When a detail is used the word **DETAIL** must appear in the credit line.
5. Full documentation credit, as supplied by the Hermitage, must appear in immediate proximity to the image, or in the section devoted to photographic credits.
6. The Hermitage reserves the right to deny permission to reproduce an image from its collection to any applicant whose product is not acceptable to the museum for any reason.
7. Permission is granted for one time use as detailed on the application form. Permission to publish must be obtained in advance for each subsequent edition or reprint.
8. Permission is valid only for the individual, company, or, institution to who it is specifically issued and may not be transferred, assigned, sold, or otherwise disposed of without written permission of the Hermitage.
9. In the case where copyright is held by a third party, written permission must be secured by the applicant from that party or their agent, and must accompany the application.
